MANAGER'S REPORT- Chairman Lewis asked County Manager Weeks for his report. Weeks stated that he received the EMS report for November. Total calls 25, 16 transports, 3 refusals, and 6 cancellations. Average response time was 9 minutes. We provided mutual aid 9 times and we did not receive/request any mutual aid.

<u>CDBG FOR COMMUNITY CENTER PROJECT</u>-Weeks stated that RVRC has put the Community Center project out for bid to find an architect. This was put out to bid previously and no bids were received. This project is to expand the Community Center and add a covered area for the commodities that are given out each month.

ENERGY EFFICENCY GRANT FOR COURTHOUSE-Weeks explained that all the paperwork for the \$150,000.00 grant that we applied for has been completed and submitted. There will be a meeting held between Weeks, RVRC, and GEFA to set the budget this week. The goal is once the budget is set and approved by GEFA to have that project underway by July 2025.

**KIDS CHRISTMAS**-Weeks stated that all the boxes that are sitting around in the hall and boardroom are toys that have been donated for the annual Kids Christmas to be held on Friday December 20, 2024. Weeks invited everyone to bring their kids out to come see Santa and get a toy.
