<u>PUBLIC HEARING-</u> Chairman Lewis opened the public hearing for HB 581 Homestead Exemption. Chairman Lewis asked if there were any comments or questions on HB 581. After hearing none this public hearing was closed.

Chairman Lewis opened the public hearing for the rezoning application on Tanglewood Trail. The zoning application is to change the zoning from A-1 to R-1. MANAGER'S REPORT- Chairman Lewis asked County Manager Weeks for his report. Weeks stated that he received the EMS report for January. Total calls 37, 18 transports, 11 refusals, and 8 cancellations. The average response time was 10 minutes. We provided mutual aid 14 times, and we received mutual aid 2 times.

ENERGY EFFICIENCY GRANT FOR COURTHOUSE-Weeks stated that the energy efficiency grant on the Courthouse is moving forward. The next step will be to have an energy audit done to see more specifically what our needs are. Weeks thinks that they are going to partner with other local Governments in our area to make it more attractive to the ones that would do the audit.

<u>DEER POINT RD. AND MOSSY OAK CULVERTS</u>—Weeks explained that on Deer Point Rd. and Tanglewood Trail in Mossy Oak we have major creek crossings that go under the roads. The culverts are at about 50% capacity due to silt and sand that has washed into them. He is looking for an excavator to have them cleaned out.

<u>JACQUELINE DRIVE</u>- Weeks told everyone that some tree roots have grown out in the road and caused asphalt damage on Jacqueline Dr. Weeks wanted to let the Commissioners know in case they get a call that this is being looked at and will be repaired asap.

ROAD DEPT.-Weeks said that the Road dept. has been picking up tires on the right-of-way when they have not been able to do other road work. They have picked up around 300 tires. Once they have picked up around 500 tires Weeks will call Ashberry Tire disposal to have them disposed of. Weeks said he will submit the invoice to the State for the STAR program for reimbursement.

Commissioner Baggett asked Weeks if he had an update on the Dollar Tree driveway. Weeks said he submitted everything to GDOT that they requested and has not heard anything so far, but he will be reaching back out to them to find out what the next step is.

FAMILY CONNECTIONS- Ms. Sara Lee Crumbs was present and gave an update on Family Connections. The Senior produce delivery is the 3rd Tuesday of each month in the Family Connections parking lot. Tomorrow February 12, 2025 there will be a Mobile Health van available for residents needing screenings for pregnancy, HIV/STI, PAP smears, and primary care screenings. Chairman Lewis thanked Ms. Crumbs for her report and her hard work for the Community.

4-H COORDINATOR REPORT- Mrs. Young was present and gave an update on 4-H. Mrs. Young talked about the second STEM club meeting and what a fun time it was. Mrs. Young went and looked at River Bluff park to hold a bike-a-thon for a fundraiser to help the kids go to camp. She has about 30 kids signed up to go to camp which is about double from last year. Mrs. Young stated that the strawberries should be in the first week of March. She thanked County Manager Weeks for going with her to the park to look at where the bike-a-thon will be held. She also thanked everyone for their support and help with everything. Commissioner Baggett asked how much it is to sponsor a child to go to camp. Mrs. Young said that the total cost is \$450.00 dollars. Chairman Lewis thanked Mrs. Young for her hard work and report.
